The revised SPP has changed the wording in relation to the protection of playing fields etc, by referring to the protection applying to 'outdoor sports facilities' (see para 226 of the SPP) which is then defined in the glossary to it. To be consistent with this it would make sense that the LDP uses similar wording.

Make reference to 'outdoor sports facilities' instead of 'playing fields'/'sports pitches' and include the SPP definition of 'outdoor sports facilities' in the glossary to the LDP.

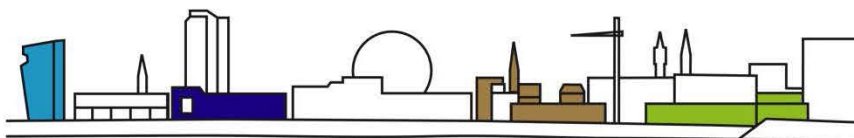

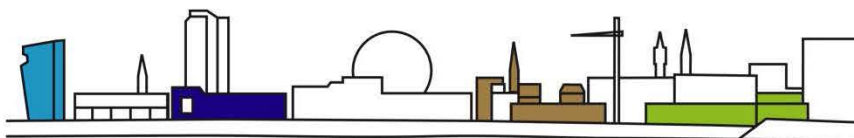
