

What would you like to say about the issue?

This site was previously assessed as unsuitable in an earlier LDP due to a number of issues. I believe these have been published in a report before.
The site is a greenfield site - located in an area of woodland to the Northwest of the village. As a green space it is a local amenity being enjoyed by walkers and people out horse riding.
It is very much on the fringe of the village and does not have good access to the rest of it. To get from the site to the shops on North Deeside Road you have to cross Malcolm Road twice. (There is not a continuous length of pavement along Malcolm Road.) Given the volume of traffic, which comprises a large amount of HGVs, this is not very safe - especially for children.
Malcolm Road is already a busy road and has an awkward junction with North Deeside Road. Extra homes will only make the problem worse. Furthermore the site is not served by public transport - the nearest bus stop being a good distance away and not connected by pavement. (see point above) This means it would cause an increase in traffic for the village - whether for shopping, or the morning and afternoon school runs.
The site is also not connected to mains drainage.
