The aim is to introduce a policy determining how any surplus income resulting from enforcement of the Aberdeen Low Emission Zone (LEZ) should be used. In accordance with the Transport (Scotland) Act 2019, any surplus income remaining once the operational costs of the LEZ have been covered can

be used by the local authority towards measures that directly or indirectly contribute towards the scheme objectives.

ACC has therefore developed a policy that will see any net surplus income directed towards projects that further contribute towards air quality improvement within the LEZ and/or the wider city centre Air Quality Management Area (AQMA).

Poor air quality is known to result in disproportionate negative health impacts amongst some groups with protected characteristics, namely the young, the elderly, pregnant women, those with preexisting health conditions, certain race groups and those suffering from socio-economic disadvantage. Measures to improve air quality will therefore have positive health impacts on such groups. As projects are identified and delivered, further research will be carried out to ensure that these projects will benefit groups with protected characteristics from the proposed policy.
