

Integrated Impact Assessment

Impacts

2.2 In what way will the policy impact people with these protected characteristics?

The budget proposal would result in a very significant reduction in capital funding across a number of rolling programme budgets which are primarily related to property, roads and fleet. The indicative amount of financial saving is approximately equivalent to reducing current budgets by a third of the value of planned improvement works across the three areas.

A reduced budget would mean the 'waiting time' for works to be carried out would have to increase. High risk impact on net zero route.

The projects included within the Condition & Suitability Programme can positively impact on protected characteristics e.g. Accessibility improvements would positively impact on Age and Disability.

It is not possible to determine which projects specifically would not be included in the programme. Given there is a project prioritisation process in place and the proposed reduction is very significant, it is considered that there would be a high negative impact on the protected characteristics of Age and Disability, in light of the expected increase in 'waiting time'.

3.2 In what way will the policy impact people experiencing socio-economic disadvantage?

The budget proposal would result in a very significant reduction in capital funding across a number of rolling programme budgets which are primarily related to property, roads and fleet. The indicative amount of financial saving is approximately equivalent to reducing current budgets by a third of the value of planned improvement works across the three areas.

A smaller budget would mean the 'waiting time' for works to be carried out would have to increase. High risk impact on net zero route.

The projects included within the Condition & Suitability Programme can positively impact on protected characteristics e.g. Accessibility improvements would positively impact on Age and Disability.

It is not possible to determine which projects specifically would not be included in the programme. Given there is a project prioritisation process in place and the proposed reduction is significant, it is considered that there would be a high negative impact on the protected characteristics of Age and Disability, in light of the expected increase in 'waiting time', with specific regard to the 'rolling programme referenced as 'Corporate Property Condition & Suitability'.

The indicative amount of financial saving is approximately equivalent to reducing current budgets by a third of the value of planned improvement works across the three areas.

A reduced budget would mean the 'waiting time' for works to be carried out would have to increase. High risk impact on net zero route.

Reducing the budget which is related to fleet will lead to a delay in the Council's conversion of its vehicles to be able to use alternative fuels such as electricity or hydrogen. In theory, fleet conversion budget cuts will reduce the Council's fleet contribution in reducing carbon emissions and thereby retaining the reliance on fossil fuels over a longer period.

Similarly the same principle will apply if there was any reduction to the 'Corporate Property Condition and Suitability' budget, with regard to any work related energy-saving improvements that may apply to buildings.
