Vision

- 2.1 What do you think are the most important things that make Aberdeen a good place to live, visit and/or work?
 - Access to wide varied greens space, for example: Hazelhead Park, Westfield Park and the various golf courses run by Sport Aberdeen
 - Beach and Beach Boulevard
 - Good access to the wider area out with the city
- 2.2 What do you think should be the Council's top priorities for the next Aberdeen Local Development Plan?

 - Provision of more affordable housing by the council and also private developers
 Reduced priorities for private housing developers
 A change in approach to housing, it's easy to build thousands of properties through private development but it's another to fill them and make them affordable. Currently it seems that ACC is only interested in figures and how many houses the city can boast.
- More emphasis put on private developers to provide for the community in the event of private developments being accepted and not just build provate houses

 - Protection of green space within the city as a whole

 - Development of green space access making parks easier to visit and spend time in
- Development of green space areas making them more appealing to residents and
- elapment of Union Street in particular making it more attractable to businesses to Investment in the Aberdeen Harbour area
- 2.3 Do you have any particular aspirations for your community or Aberdeen as a whole that you think should be taken forward through the ALDP? For example, what are your views on recycling of waste, affordable housing, access to green space or ways to reduce CO, emissions?
- Green spaces must be protected at all costs, they are at the heart of communtities and encourage residents to stay locally
- Aberdeen should pave the way in recycling especially given it's new recycling plant in Altens. Access to local recycling areas needs to be protected and more provisions made for those not able to reach these areas affordably.
- Affordable housing is a huge issue in Aberdeen and must be tackled, the huge surge in private developments in and around the city is saturating the market and pricing most normal families out of the market not to mention devaluing many of the properties already in excistance.
- ACC needs to invest in it's poorer communities and help inprove infrastructure, appearance, resources and housing.

Policy Topic Areas

What do you think should be our main planning priorities for...

- 2.4 ...the City Centre? (For example, what should the role of Union Street be? Does the City Centre have all the uses we want, or should there be more uses there and if so where could they go?)
- Top of the list needs to be Union Street, it's continual decline is shocking and too much emphasis is put on shopping centres and areas out with Union Street. This should be the heart of the city attracting residents and visitors alike, it's currently a granite morgue propped up by To Let signs and empty business units.
- Better parking provisions for all city centre users
 More affordable parking provisions in and around the city centre
- 2.5 ...providing infrastructure? (For example, how should new infrastructure be provided and how might it be paid for?)
 - Development of the Haudigan as already planned but to ensure that this does happen.
- Development of the Berryden Corridor to ensure better access into the city centre
- Ensure access to the AWPR from all areas of the city is the best it can be and improve where potential pinch points may occur

It's not up to me to suggest how it is paid for, that's the job of the elected members and not a question that should be asked of residents of the city.

- 2.6 ...transport and accessibility? (For example, how can we make it easier to travel in and around Aberdeen? Should we look at pedestrianisation in the City Centre?)
 - Union Street should not be pedestrianised and this should certainly not be on the cards. All over the country the decline of main streets through pedestrianisation is very evident, do not make the same mistake as the likes of Inverness.
 - I agree certain streets I the city centre around Union Street could be pedestrianised or made into bus/taxi only zones but not to the detriment of free flowing traffic.
- Unless the provision of a decent bus service from all areas of the city is improved, pedestrianisation of any area of the City Centre especially Union Street will only drive people away and stop them coming in as frequently as the do just now.

- 2.7 ...ensuring we have high quality buildings and places? (For example, how can we better protect our built heritage and ensure high quality and sympathetic architecture and landscape design?)
 - That would be the role of the planning department to ensure that all developments within areas of heritage are kept within strict perametres and within the keeping of the area and surroundings.
 - More emphasis put on protecting older buildings and applications for listed status being made
 - Discouragement of developers wishing to knock down and start again with more emphasis put on regeneration of existing builders and stock
- 2.8 ...meeting the needs of business and industry? (For example, what can be done to retain existing businesses and attract new employment opportunities to Aberdeen?)
- Make it fininacially viable for businesses to invest in the area, don't cripple them with huge business rates. What's the point in having huge areas for businesses when they sit empty
- Focus on what the city does have and push businesses towards utilising current stock before building from scratch.
- 2.9 ...meeting Aberdeen's housing and community needs? (For example, how can we meet the needs of people who cannot afford mainstream housing?)
- Force developers to provide more affordable housing in all areas
- Redevelopment of existing housing that currently sits empty or under utilised
